Pursuant to Section 86 [Alternative Approval Process] of the *Community Charter*, the Council of the City of West Kelowna intends to adopt Bylaw No. 0196, authorizing the borrowing of a sum not exceeding TEN MILLION, FIVE HUNDRED THOUSAND DOLLARS (\$10,500,000.00) to be repaid over a period not exceeding 30 years, for the construction of a new City Hall and related project work.

Instructions

1. If you are opposed to the borrowing of a total sum not exceeding \$10,500,000.00 for the construction of a new City Hall and related project work, and you qualify as an elector of the City of West Kelowna, you may sign an Alternative Approval Process Elector Response Form.
 2. If you are NOT opposed to the borrowing of a sum not exceeding \$10,500,000.00 for the construction of a new City Hall and related project work, you need do nothing.
 3. Forms are available at the City of West Kelowna, 2760 Cameron Road, West Kelowna, BC V1Z 2T6 between 8:30 a.m. and 4:30 p.m., Monday to Friday (excluding statutory holidays) or on the City's website at www.westkelownacity.ca beginning on Wednesday, March 23, 2016.
 4. To sign an Elector Response Form, you MUST meet the qualifications as either a Resident Elector or a Non-Resident (Property) Elector of the City of West Kelowna. If you are unsure if you qualify, please contact the City of West Kelowna at 778-797-2250.
 5. A person who obtains an Elector Response Form may make accurate copies of the form.
 6. Each Elector Response Form may be signed by one elector of the City of West Kelowna.

Elector Response Forms must be received by the Corporate Officer, either by delivery or regular mail, at 2760 Cameron Road, West Kelowna, BC V1Z 2T6 on or before 4:00 p.m. on Tuesday, May 3, 2016 to be considered.

No faxed or e-mailed Elector Response Forms will be accepted. Electoral Response Forms MUST have an original signature.

The number of electors in the City of West Kelowna is estimated to be 26,034. If ten percent (10%) [2,603 electors] of the estimated number of electors in the City of West Kelowna sign an Elector Response Form in opposition to the adoption of Bylaw No. 0196 to borrow a sum not exceeding \$10,500,000 for the construction of a new City Hall and related project work, the City of West Kelowna cannot proceed without receiving the assent of the electors by referendum.
